**INDIVIDUAL TAX RETURN ENGAGEMENT LETTER – 2025 TAX YEAR**

Dear Client:

This letter is to confirm and specify the terms of my engagement with you and to clarify the nature and extent of the services I will provide. In order to ensure an understanding of our mutual responsibilities, I ask all clients for whom returns are prepared to confirm the following arrangements.

I will prepare the appropriate federal and requested state income tax returns, from information that you will provide to me. I will not audit or otherwise verify the data you submit, although it may be necessary to request clarification of some of the information. I will provide you with questionnaires and/or worksheets to guide you in gathering the necessary information. Your use of such forms will assist in keeping pertinent information from being overlooked.

It is your responsibility to provide all the information required for the preparation of complete and accurate returns. You should retain all the documents, canceled checks and other data that form the basis of income and deductions. These may be necessary to prove the accuracy and completeness of the returns to a taxing authority. **You have the final responsibility for the income tax returns and, therefore, you should carefully review them before you sign them.**

My work in connection with the preparation of your income tax returns does not include any procedures designed to discover defalcations or other irregularities, should any exist. However, should I find any irregularities or unusual items I will bring them to your attention. I will render such accounting and bookkeeping assistance as determined to be necessary for preparation of the income tax returns. If I discover any errors or omissions on a prior year tax returns I will bring them to your attention.

I will use professional judgment in resolving questions where the tax law is unclear, or where there may be conflicts between the taxing authorities' interpretations of the law and other supportable positions. Unless otherwise instructed by you, I will resolve such questions in your favor whenever possible.

The filing deadline for the tax returns is **April 15, 2026**. In order to meet this filing deadline, the information and documents needed to complete the returns should be received in this office no later than **March 20, 2026**. Extensions will be filed for all clients who have not provided all document/information for filing 2025 tax returns by **March 20, 2026**.

**If an extension of the time is required, any tax due with these returns must be paid with that extension. Any amounts not paid by the filing deadline may be subject to interest and late payment penalties.**

The law provides various penalties that may be imposed when taxpayers understate their tax liability. If you would like information on the amount or the circumstances of these penalties, please contact me.

Your returns may be selected for review by the taxing authorities. Any proposed adjustments by the examining agent are subject to certain rights of appeal. In the event of such governmental tax examination, I will be available, upon request, to guide you through the process.

You understand that your income tax returns will be electronically filed through a secured third party filing service.

My fee for these services will be based upon the complexity of the tax return. A retainer of \$100 is due when you submit your data to me. The balance will be required to be paid before electronic filing of the return or sending of final tax return documents (in cases where you are required to mail your return or go to an IRS center to submit your returns) to you. All invoices are due and payable upon presentation.

If the foregoing fairly sets forth your understanding, please sign the enclosed copy of this letter in the space indicated and return it to my office. However, if there are other tax returns you expect me to prepare, such as prior year amendments, please inform me by noting so just below your signature at the end of the returned copy of this letter.

I want to express our appreciation for this opportunity to work with you.
